This License Agreement is assignable by the Licensee(s) without my/our consent to allow for Performer(s) or their assigns and sub-licensees to market and sell recordings of the Song. It cannot be assigned to other performers without my/our written consent.

The invalidity or unenforceability of any provision of this License Agreement shall not affect the validity or enforceability of any other provision of this License Agreement. If any provision of this License Agreement shall be held invalid or unenforceable in part, the remaining portion of such provision, together with all other provisions of this License Agreement, shall remain valid and enforceable and continue in full force and effect to the fullest extent consistent with law.

Each person signing below represents that they have read this License Agreement, are of legal age and understand that this License Agreement is binding without any restrictions on use and is binding on their heirs, legal representatives and assigns. All Songwriters and Performers must sign this License Agreement. If there are more than two Performers, there are additional places for them to sign at the bottom of this form. Alternatively, if any Songwriter is a minor, their parent or guardian, in signing below represents that he or she is the parent or legal guardian of the minor and that he or she has read this License Agreement and understands that this License Agreement is binding without any restrictions on use.
